WAIVER OF LIABILITY AND ASSUMPTION OF RISK

Although Jump for Joy (BellBunch, LLC) strives to make all activities as safe as possible, inflatable play structures of this nature do come with an element of risk.

Consequently, and in consideration of the opportunity to use the facility and all of its amenities and/or participate in any parties or activities at Jump for Joy, I, for myself, my child or ward sign this Waiver of Liability and Assumption of Risk.

I, for myself, my child or ward agree to follow all safety instructions posted/provided and acknowledge that failure to do so may result in expulsion from Jump for Joy without refund. I also acknowledge that it is my responsibility to supervise my child(ren) or ward(s) the entire time we/they are on the property of Jump for Joy.

I, for myself, my child or ward acknowledge and understand that there are dangers and risks associated with the activities at Jump for Joy, and agree to assume any and all responsibility and risk of personal injury, including (without limitation) the potential for paralysis and death.

I, for myself, my child or ward certify the participant(s) is/are physically fit to participate in any and all activities at Jump for Joy. It is up to me to know the limits of myself, my child or ward and know when it is no longer safe for me/them to participate.

I, for myself, my child or ward, and on behalf of my or their heirs, assigns, personal representative(s) and next of kin, HEREBY HOLD HARMLESS Jump for Joy, BellBunch LLC, its owners, members, officers, employees, agents and contractors.

Each provision of this Waiver of Liability and Assumption of Risk shall be considered separable, and if for any reason any provision or provisions of this Waiver of Liability and Assumption of Risk are determined to be invalid or contrary to any existing or future law, the invalidity shall not affect or impair the operation of those portions of this Waiver of Liability and Assumption of Risk that are valid.

I AGREE AND UNDERSTAND THIS WAIVER OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT IS BINDING ON MYSELF, MY CHILD OR WARD, AND THE HEIRS, SUCCESSORS AND ASSIGNS OF MYSELF AND MY CHILD OR WARD, AND BY SIGNING, I CERTIFY THAT I AM THE LEGAL PARENT OR GUARDIAN OF THE CHILD FOR WHOM I AM SIGNING OR, IF I AM NOT THE PARENT OR LEGAL GUARDIAN OF THE CHILD, THAT I HAVE THE EXPRESS PERMISSION OF THE CHILD'S LEGAL PARENT OR GUARDIAN. IF YOU ARE NOT THE PARENT/LEGAL GUARDIAN OR DON'T HAVE EXPRESSED PERMISSION OF A CHILD'S LEGAL PARENT OR GUARDIAN, YOU CANNOT SIGN FOR THAT CHILD AND THEY ARE NOT ALLOWED TO ENTER THE JUMP ROOM.

SOCKS ARE REQUIRED at all times while on/in the inflatables.

NO RUNNING INSIDE THE BUILDING.

NO FOOD, DRINKS or GUM are allowed in the Jump Room – NO EXCEPTIONS.

(All eating and drinking will be done in the lobby area or Party Room.)

NO SHOES or SHARP OBJECTS (such as belts, watches, glasses, earrings, etc.) ARE ALLOWED NEAR THE INFLATABLES.

(These items can cause damage to the inflatables and/or injure yourself or third parties.)

You will be held responsible for any damage(s)/injuries caused by you, your child or ward.

Waivers must be completed for each ADULT AND CHILD who will get on/in the inflatables before entering the Jump Room on each visit to Jump for Joy.
